

# CEP's Objectives and Programs

CEP is a five year USAID-funded program in Macedonia that works to achieve two objectives:

- strengthen the constructive engagement by civil society organizations (CSOs) on policies and issues of public concern, and
- increases and sustains youth involvement in public life in Macedonia.

CEP's main goal is to enhance the capacity of CSOs and youth groups to advance public policies, improve public services, promote good governance, and contribute to improving the standard of living in Macedonia. CEP is committed to gender equity and the protection of the rights of socially excluded groups in the country.

CEP began its work in August 2016. It is implemented by East West Management Institute (EWMI), in partnership with four local CSOs: the Foundation for Internet and Society "Metamorphosis", the Association for Democratic Initiatives (ADI), the Foundation "Open Society in Macedonia" (FOSM), and the National Youth Council of Macedonia (NYCM).

EWMI is a New York-based independent, not-for-profit organization that works to strengthen democratic societies by bringing together government, civil society and the private sectors to build accountable, capable, and transparent institutions that serve the people's best interest.

## To achieve its objectives, CEP implements activities under four components:

- √ Strengthen CSO alliances, implemented by "Metamorphosis";
- √ Strengthen CSOs, implemented by "Metamorphosis" and ADI;
- √ Strengthen youth engagement, implemented by NYCM, and
- √ Strengthen youth activism, implemented by ADI.

## FOSM is responsible for coordinating CEP's capacity development assistance for all CEP grantees.

# Grant Opportunities

CEP provides multiple opportunities for grant support to Macedonia's CSOs and CSO alliances, including youth CSOs, as well as to individual young men and women. These opportunities include:

- **Partnership Grants (PGs)** that support CSO alliances to: become leaders in shaping and constructively engaging in issues of public concern; enhance their capacity to engage citizens, the media, government institutions, and other stakeholders in advancing

public wellbeing; and strengthen their institutional capacity.

- **Strategic Support Grants (SSGs)** that support CSOs, including think tanks, that work to promote good governance, public service improvement, rule of law, anti-corruption, human rights, economic growth, business enabling environment, and monitoring and oversight of public institutions.
- **Youth Engagement Support Grants (YESGs)** that support initiatives by formal and informal youth groups that focus on: educating youth about their rights and opportunities for public participation; engaging

youth in using existing mechanisms for civic participation and accountability to advocate with public institutions regarding issues of priority concern for youth or the community at large, as well as to monitor public institutions; providing youth with opportunities to give back to communities and the society, and prioritizing issues that might impact their lives.

- **LEAD MK Annual Fellowship Program** that will equip Macedonian young people with skills, knowledge, and networking opportunities that will enable them to become leaders in advancing public interest at the community, regional, and national level.

## PREVIOUS CALLS

During October – December 2016, CEP issued Calls for Applications for all its grant programs and received:

- **14 applications for its Partnership Grants;**
- **66 applications for its Strategic Support Grants;**
- **33 applications for its Youth Engagement Support Grants; and**
- **Applications by 22 young men and women for CEP’s LEAD MK Program.**

During January – March 2017, CEP staff and experts carefully reviewed these applications and awarded, as planned, two Partnership Grants and selected 17 young men and women to participate in the LEAD MK program. CEP also completed the first selection steps for Strategic Support Grants.

## UPCOMING CALLS

In April, CEP will solicit Applications for the first round of targeted Rapid Response Grants. These grants will support initiatives by registered CSOs or non-registered organizations and groups of citizens to raise public awareness, conduct rapid policy analysis or formulation, mobilize citizens, and other initiatives to address unanticipated and important policy developments.

During April - June 2017, CEP plans to award six Strategic Support Grants, four Youth Engagement Support Grants, and four Rapid Response Grants.

## News and Stories

### CEP Information Sessions Tour

**D**uring November–December 2016, CEP staff and representatives of CEP’s implementing partners – Metamorphosis, ADI, FOSM, and NYCM – organized six information sessions throughout Macedonia to inform civil society, the private sector, media, and citizens about CEP’s goals, approach, and activities. More than 100 people attended CEP’s information sessions held in Skopje, Struga, Shtip, and Gostivar. CEP staff held three additional information sessions at American

Corners in these towns targeting young men and women that were invited to apply for participation in CEP’s LEAD MK Program and seek support for their civic initiatives from CEP’s Youth Engagement Support Grants. CEP’s Chief of Party, Ms. Ana Drakic, and USAID representatives in Macedonia addressed the participants at the information sessions and encouraged them to seek CEP’s support for their civic engagement initiatives at the community and national level.

“Citizen engagement is not a one-time thing. We are all responsible for making

sure that we are actively working to improve not only our own lives but also the lives of our community. We highly encourage you to be active, because the only way that our communities will become better is if we all participate and are actively engaged in improving the lives of ourselves, our family, and our community” - Edward Gonzalez, General Development Office (GDO) Director, USAID mission in Macedonia.

CEP will continue the Information Sessions Tour beyond March 2017 to reach out to more communities in Macedonia.

## Idea Competition Event

**B**y January 2017, 33 youth CSOs and informal youth groups submitted Project Concept Ideas in response to CEP's Call for Applications for the Youth Engagement Support Grants. 11 of these groups met the basic grant eligibility criteria and were invited to present their project ideas at CEP's Idea Competition Event organized by ADI. This public event was held on February 9 at NYCM

premises. Representatives of 11 youth CSOs presented their ideas in front of CEP's Grant Review Committee members, who provided constructive feedback on improving the proposed interventions. 24 young men and women representing CSOs from Skopje, Tetovo, Krushevo, Bitola, and Prilep presented a wide variety of interesting ideas for engaging youth in addressing priority needs at the community level, but also undertaking

advocacy initiatives that include interaction with central government institutions.

Upon completion of the Idea Competition Event, CEP invited the CSOs that presented the most effective and creative project ideas, to submit the full project application to CEP by the end of March 2017. CEP plans to award grants to the best applicants during the next quarter.

- In April, CEP will organize the LEAD Academy with the participation of 17 young men and women;
- In April, CEP will solicit Applications for the first round of targeted Rapid Response Grants;
- In May, CEP will issue the Call for Applications for the second round of its Youth Engagement Support Grants;
- In May, CEP will issue the Call for Nominations for the Youth Civic Engagement Award.
